New Subscription Rates

If you are a newly-joined Member and have set up your subscription according to the tariff shown below, you can ignore this mailing.

Dear Member,

As announced at last year's AGM and as published on our Club notice board and our website, subscription rates are changing as from 1st September 2008.

In response to Members' comments, we have created a new Family Membership option which we hope many of you with families will find convenient and economical.

The Membership categories and rates are as follows:

Membership Type	Age at 31 st August	Annual Subscription
Full Member	18 - 64	£30
Full Member + family	18 - 64	£35
Full Member (concession)	65 +	£20
Full Member (concession) + family	65 +	£25
Junior Member	12 - 17	£10

Family Membership

At present, if you are a Full Member, your spouse/civil partner (see Note 1) and children aged 12 to 17 are limited to using the Club a maximum of five times a year and only if they have been signed in as guests and are accompanied by you. (This has always been a part of Club Rules.) However, Family Membership is available for a £5 additional cost, making your spouse/civil partner and any 12 to 17-year-old children into Spouse and Junior members respectively. This entitles them to use the Club facilities unaccompanied and without signing in. Your younger children automatically become Junior Members on reaching 12 years of age. On reaching 18, children will cease to be part of a Family Membership.

If you wish to take up the Family Membership option in order to include your spouse/civil partner and/or your children, please fill in the application form overleaf and return it with your Standing Order form.

Notes:

1. *Members who already have a spouse/civil partner officially recorded as a Spouse member and who wish this arrangement to continue are kindly asked to fill in the form overleaf – you will now pay the 'Full Member + family' subscription, according to your age, as listed above.*
2. *Children aged under 12 are only allowed in the club when accompanied by, and under the control of, an appropriately responsible person who is a Member — preferably not after 9pm.*
3. *Please see the Club Rules for full details of Junior and Spouse entitlements.*

Junior Members

Persons who are 12 to 17 y.o.a., and who are not part of a Family Membership, may become/remain Junior Members in their own right. But, where appropriate, £5 can be saved by asking a parent to include you in a Family Membership!
