

Notes to Applicants for Membership of Newport Boat Club

Those applying for Club membership should complete the application form(s) and the Bankers Order and **return them all to the Club with your first cash/cheque payment**, by post to the address below. Alternatively, by hand, in the envelope provided, and post into the letterbox on the office door.

Applications are normally presented to the General Committee for ratification at the end of each month. However, 48 hours after submitting an application, applicants may start to use the Club facilities and bar.

You should ask for a membership card at the Bar; this must be kept with you at all times when visiting the Club.

*(In order to minimise voluntary admin work, you will **not** receive formal notification of membership. In the unlikely event of an application not being ratified, the Bankers Order will be cancelled and the applicant notified).*

Information about the various categories of Membership are shown below.

Family Membership

As a Full Member, your spouse/civil partner and children aged 12 to 17 are limited, as guests, to using the Club a maximum of five times a year and only if they have been signed in and are accompanied by you. **However**, Family Membership is available for a £6 additional cost, making your spouse/civil partner and any 12 to 17-year-old children into non-voting Spouse and Junior members respectively. This entitles them to use the Club facilities unaccompanied and without signing in. Your younger children automatically become Junior Members on reaching 12 years of age. (On reaching 18, children cease to be part of a Family Membership.)

If you wish to take up the Family Membership option, please fill in the additional application form enclosed and return it with your Standing Order form.

*NOTE: At all times, children aged **under** 12 are only allowed in the club when accompanied by you and under your control — preferably not after 9pm.*

Refer to the Club Rules for full details of Junior and Spouse entitlements.

*Club subscriptions, payable **in advance**, are for the year from 1st September to 31st August.*
