

-Notes to Applicants for Membership of Newport Boat Club

Those applying for Club membership should complete the application form(s) and return **to the Club**. Send by **email**, post or delivery by hand to the club office to the address below:

Once received Newport Boat Club will email you with instructions on how to set up your direct debit, to complete your payment. Please be sure to check your junk/spam folder for emails from Newport Boat Club.

After your application is submitted, and processed, instructions will be sent to you, from membership@newportboatclub.co.uk as to how to set up your direct debit. Once you have initiated the direct debit set up usually within 2 weekday working days, your membership card should be ready for you to collect at the member's bar. Please note that the Club Administration Manager works Monday to Friday.. Your application will need to be ratified at the next Management Committee meeting, however you may begin using the club facilities and bar after 48 hours. If there is an unforeseen delay to your application being processed, you may ask to be signed in as a guest in the short term until it is ready.

Communications with Members is by email so having given your email please be sure to update it when necessary.

Club Subscriptions and Joining Fee

Club subscriptions, payable **in advance**, are for the year from 1st September to 31st August. There is a £10 joining fee to cover some of the administration costs.

Full Member	£60.00 subscription + £10 joining fee (subject to change)

*Please note the joining fee for young adults is waived when they move directly from a family membership to their own at 18 years old

Your Spouse and Family

Membership includes your spouse/civil partner and any 12 to 17 year old children as non-voting Spouse and Junior members respectively. This entitles them to use the Club facilities unaccompanied and without signing in. On reaching 18, children cease to be part of a Family Membership and should become a Young Adult Member. Children aged under 12 are only allowed in the Club when accompanied by, and under the control of a responsible Member — preferably not after 9pm. If you wish your Spouse to have a Club Card please fill in the additional Spouse and Family Information form enclosed and return it with your form.

Visitors

We welcome your visitors, but they are limited to using the Club a maximum of five times a year, only if they have been signed in as guests and are accompanied by you.

Membership Cards

These are issued to the Member and spouse. We do not currently issue Membership cards to those under 18. Lost cards can be replaced at a cost of £5.00 per card.
